5.0	<p>Best Practice Proposal TR 2015-01 – Champion: Sat Viridi</p> <p>Purpose: To utilize electronic devices suitable for viewing locate sheets on site during excavation.</p> <p>Origin/Rationale: To develop an industry standard with respect to an acceptable size of the viewing screen of electronic devices for the purpose described above. Additionally this standard shall reflect the accountability of excavators following ORCGA best practices and regulatory protocol. The industry should determine whether or not electronic devices are more or just as suitable as a paper copy of locates; namely with respect to efficiency, clarity, and validity</p> <ul style="list-style-type: none"> • John Todorovski presented this BP proposal • He discussed the size of electronic device that will be acceptable • Weather – when it rains ipads need to be put away, however so does paper • Battery issues/breakage • Wifi capability • Pros/cons need to be discussed <p>Comments:</p> <ul style="list-style-type: none"> • Paper copy still with the excavator • Confirm do you have a valid locate • Is the locate accessible • If you can't access it and read it, it is not a valid locate • Locates are being received electronically so why should we need to print it • Paper copies can be destroyed as easily as an electronic methods • Parameters need to be set. • As long as something is on site and the plant it clearly identified • How is the data shared? Is it easily adaptable? • What size is acceptable for a locate to be valid? e.g. size of a postage stamp is unacceptable. • How much of the locate sheet should you be able to see to make it valid? • Transparent Earth – this is a new application that will show you the infrastructure below the ground. It works better on a screen larger than 7" • Should we as a BP committee be stating the size of the device used? • If you can't read it – the locate is not valid • Should we set a scale? <p>Consensus was reached that this BP Proposal be assigned to a task team</p> <ul style="list-style-type: none"> • Task Team created • Sat Viridi/John Todorovski (Lead)
