4. OOC / Bill 93 Presentation - Ben Hamilton

Bill 93 has changed a lot of things -

Sharing of locates with subcontractors is allowed

Members must have a 60 day validity period for their locates

Two major parts is Dedicate Locator and compliance

Dedicated Locator has a lot of moving parts.

Certain regulations are in place for project owners and members responding to request Project owners to

All agreements can be done in advance of filing of locates provide 90 day notice

Best Practices should include dedicated locator

Compliance

Regulations being developed, effective start of 2023. Ministry conducted targeted consultation and feedback with industry.

If a member is going to be late delivering a locate they are required to notify OOC.

Bill 93 creates a process for excavators to seek damages from members for demonstrated financial loss. Member is liable through OOC process

Based on a report OOC will make an assessment on a compliance level and lay a penalty.

- All members are included in Bill 93 with the exception of transmission pipelines.
- 90 Day Notice OOC process is to gather information, identify members in the area, line everything up and transfer the process.
- OOC Dedicated Locator team for information ontarioonecall.ca/DL

Ouestions and Comments

- Is there a mechanism to allow the sharing of locates to happen?
 - Add another party after the request is made. Not part of the initial request.
- Sharing of Locates is relevant and timely. Begin work on this as a TR. Produce guidance as part of the locate package.
- **Training & Certification**

Currently defaulting to LAC.

ORCGA has current DPT program and is working with others to develop a more robust program.

If markings are gone the locates are expired.
