4. CCGA National BP Committee Update: Gordon Campbell

- New CCGA Executive Director – Todd Scott executivedirector@canadiancga.ca
- CCGA is working on a new strategy plan. They have sent out a survey to see where the members would like the CCGA to focus on or towards.
- Gord has asked for a mandate from the Board on what they would like the Best Practice committee to focus on.
- Alberta and Quebec are doing their own BP Book
- ORCGA Best Practice committee discussed the importance of the BP Book and since 2 of the provinces are doing their own, should the ORCGA go back to doing theirs while supporting the National BP Book? Doug will present to the Board.

5. Review CCGA National BP TR's

- a. CCGA Best Practice Proposal – TR – 114 (ATLCGA)
 - i. Locate Methods BP 3-11
- Remove the 1st part to be less detailed

Active locating is more reliable than passive locating. Active signals are generated by applying a signal from the transmitter to a conductor. Passive signals originate from sources other than the transmitter (e.g., radio towers, energized cables).

- b. CCGA Best Practice Proposal - TR – 115 (ATLCGA)
 - i. Gathering Information for Design or Planning Purposes BP 1-4
- These are editorial changes and do not need a TR.
- Agree with the He/She being changed to their

- PLANNER in NOT in the glossary – would need to be added
- c. CCGA Best Practice Proposal - TR - 116 (ATLCGA)
 - i. [Use of Records](#) [BP 3.1](#)
- Run on sentence
 - o when as-built/as constructed records are available on-site but there exists no electromagnetic or alternative technique to physically locate the facility, it may be necessary to delay the completion of the locate while archives are accessed, requiring immediate notification of all parties."
- What is the intent of the last paragraph

- d. CCGA Best Practice Proposal – TR – 117 (BCCGA)
 - i. [Locate Flag Removal](#) [BP 4-37](#)
- We do not support this Best Practice
- We felt that there is no clear direction on who removes the flags and when.
- There could be a lot of people working in a complex area with too many sub-contractors.
- If they want someone to remove the flags it should be the LSP or the Utility.
- If this is an issue in a certain area it should outline this in the tender.
- Suggest adding "when feasible" and remove sentence "leaving.....future"
- The BP book was created for damage prevention of utilities not animals.
